**RESOLUTION TO RECOGNIZE REVENUE AND APPROPRIATE EXPENDITURES IN THE AMOUNT OF \$90,000 FOR ADDITIONAL FUNDING AS CONTRACTED WITH COLORADO DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT (CDPHE).**

**WHEREAS**, El Paso County Public Health and CDPHE entered into Contractual Agreements for funding effective with the Federal Fiscal Year ending September 30, 2019 for the purposes of the Women, Infant and Children Program (WIC); and

**WHEREAS**, CDPHE provided additional funding in the amount of \$65,000 within the WIC contract to be used for the purchase of computer replacements; and

**WHEREAS**, CDPHE provided additional funding in the amount of \$25,000 for the WIC Breastfeeding Peer Counselor Contract due to the program being selected to provide breastfeeding support for the women in Boulder County through the services of a texting platform that is presently utilized by El Paso County WIC Breastfeeding Peer Counselors; and

**WHEREAS**, El Paso County Public Health is requesting the Board of Health to recognize revenue in the amount of \$90,000 and appropriate expenditures in the amount of \$90,000 to the 2019 budget to fund the cost of providing the agreed upon services and tasks in the various contracts as described; and

**NOW, THEREFORE, BE IT RESOLVED** that the El Paso County Board of Health does hereby recognize revenue in the amount of \$90,000 and appropriate expenditures in the amount of \$90,00 to the El Paso County Department of Public Health and Environmental Services 2019 budget in the following manner:


