

**RESOLUTION NO.: 2009-12**  
**SUBJECT: Amendment to Chapter 6 Body Art Regulations**  
**EFFECTIVE DATE: July 20, 2009**

**RESOLUTION OF THE EL PASO COUNTY**  
**BOARD OF HEALTH**

**WHEREAS**, pursuant to Subpart 3 of Part 5 of Title 25, C.R.S., the El Paso County Board of Health (“Board of Health”) has the power and duty to adopt regulations to initiate and carry out health programs that it deems necessary or desirable for the protection of public health and the control of disease in El Paso County; and,

**WHEREAS**, pursuant to Section 25-1-508(5)(j), C.R.S., the Board of Health has the power and duty to provide environmental health services in El Paso County; and,

**WHEREAS**, pursuant to Section 25-4-2101, C.R.S., the Board of Health has authority to adopt standards for body art that are at least as stringent as the standards imposed by the Colorado Department of Public Health and Environment; and,

**WHEREAS**, the Board of Health previously adopted El Paso County Board of Health Regulations, Chapter 6 Body Art Regulations relating to regulation of body art establishments in El Paso County; and,

**WHEREAS**, the El Paso County Department of Health and Environment (“Health Department”) has recommended that said Body Art Regulations be amended to extend the license period for body art establishments duly licensed between June 1, 2008 through May 31, 2009, to December 31, 2009, without further fees or other requirements except as to compliance with all other regulatory requirements; and,

**WHEREAS**, the Board of Health conducted a public hearing on July 20, 2009, and, has received and considered public comments relating to the Health Department’s proposal;

**NOW, THEREFORE, BE IT RESOLVED BY THE EL PASO COUNTY BOARD OF HEALTH:**

1. That El Paso County Board of Health Regulations, Chapter 6 Body Art Regulations, shall be amended, effective immediately, as follows:

**SECTION 6.15: FEES**

.....

- B. A Body Art Establishment License fee, as approved by the Board of Health, shall be charged to Body Art Establishment operators. Licenses shall be valid for the 12 month period beginning January 1<sup>st</sup> of each year and ending on December

31<sup>st</sup> of the same year. When a license is valid for only a portion of the aforementioned 12 month period, there shall be no reduction of the license fee. Each Body Art Establishment operator shall file a license renewal application and license fee with the Health Department no later than December 31<sup>st</sup> of each year, if the Body Art Establishment is to remain open after that date. A Body Art Establishment license is valid only for the original applicant and one location, and is not transferable in any manner.

2. That the license period for body art establishments duly licensed between June 1, 2008 through May 31, 2009, is hereby extended to December 31, 2009, without further fees or other requirements, except as to compliance with all other regulatory requirements.
