SUBJECT: Public Hearing for On-site Wastewater Treatment Systems Regulations

RESOLUTION OF THE EL PASO COUNTY
BOARD OF HEALTH

WHEREAS, pursuant to Section 25-1-506(3)(b)(XI), C.R.S., the El Paso County Board of Health (“Board of Health”) has the power and duty to initiate and carry out health programs consistent with state law that are necessary or desirable to protect public health and the environment; and,

WHEREAS, pursuant to Section 25-1-508(5)(g), C.R.S., the Board of Health has the power and duty to adopt rules not inconsistent with the public health laws of this state; and,

WHEREAS, pursuant to Section 25-1-508(5)(j), C.R.S., the Board of Health has the power and duty to provide environmental health services in El Paso County to carry out its powers and duties; and,

WHEREAS, pursuant to Section 25-10-104(2), C.R.S., local boards of health in Colorado are required to adopt on-site wastewater treatment systems regulations that comply with rules adopted by the Colorado Water Quality Control Commission; and,

WHEREAS, the Colorado Water Quality Control Commission made substantial amendments to such rules in 2013, necessitating complete revision to the current Board of Health regulations pertaining to on-site wastewater treatment systems; and,

WHEREAS, El Paso County Public Health (“Public Health”) has recommended that the Board of Health amend El Paso County Board of Health Regulations Chapter 8 On-Site Wastewater Treatment Systems Regulations in order to comply with the Colorado Water Quality Control Commission on-site wastewater treatment systems rules adopted in 2013, as indicated in [Attachment “A”](#) hereto, and incorporated herein by reference; and,

WHEREAS, the Board of Health has determined that it is appropriate to conduct a public hearing to consider adoption of said On-site Wastewater Systems Regulations as it deems appropriate, following said public hearing.

NOW, THEREFORE, BE IT RESOLVED BY THE EL PASO COUNTY BOARD OF HEALTH:

1. That the Board of Health shall conduct a public hearing on Monday, February 24, 2014, commencing at about 2:30 p.m. at the El Paso County Citizens Service Center, 1675 West Garden of the Gods Road, Suite 1044 Colorado Springs, Colorado, to consider

amendment to Chapter 8 "On-site Wastewater Treatment Systems Regulations", as indicated in Attachment "A" hereto, and incorporated herein by reference.


2. That it is the intent of the Board of Health to consider repeal in whole of the current El Paso County Board of Health Regulation 8 "On-site Wastewater Treatment Systems Regulations", and to consider enactment in its place of an amended [Chapter 8 "On-site Wastewater Treatment Systems Regulations"](#), as indicated in Attachment "A".


3. That following said hearing, the Board of Health shall adopt such regulations as it deems appropriate.

4. That Public Health shall advertise said public hearing as provided by law.
