SUBJECT: Public Hearing for Body Art Regulations  
EFFECTIVE DATE: July 27, 2016

**RESOLUTION OF THE EL PASO COUNTY**  
**BOARD OF HEALTH**

**WHEREAS**, pursuant to Section 25-1-506(3)(b)(XI), C.R.S., the El Paso County Board of Health (“Board of Health”) has the power and duty to initiate and carry out health programs consistent with state law that are necessary or desirable to protect public health and the environment; and,

**WHEREAS**, pursuant to Section 25-1-508(5)(g), C.R.S., the Board of Health has the power and duty to adopt rules not inconsistent with the public health laws of this state; and,

**WHEREAS**, pursuant to Section 25-4-2101, C.R.S., the Board of Health may adopt and enforce resolutions or rules that impose standards for body art that are at least as stringent as the standards imposed by rules adopted by the Colorado Board of Health; and

**WHEREAS**, pursuant to Section 25-1-508(5)(j), C.R.S., the Board of Health has the power and duty to provide environmental health services in El Paso County to carry out its powers and duties; and,

**WHEREAS**, based on an initial review of the current regulations, it has been determined that revisions are necessary to the Chapter 6 Body Art Regulations, since they were last amended by the Board of Health in December of 2010; and,

**WHEREAS**, El Paso County Public Health (“Public Health”) has recommended that the Board of Health amend El Paso County Board of Health Regulations Chapter 6 Body Art Regulations; and,

**WHEREAS**, the Board of Health has determined that it is appropriate to conduct a public hearing to consider adoption of said Body Art Regulations as it deems appropriate, following said public hearing.

**NOW, THEREFORE, BE IT RESOLVED BY THE EL PASO COUNTY BOARD OF HEALTH:**

1. That the Board of Health shall conduct a public hearing on Wednesday, August 24, 2016, commencing at about 7:30am at the El Paso County Citizens Service Center, 1675 West Garden of the Gods Road, Suite 1044 Colorado Springs, Colorado, to consider

amendments to Chapter 6 "Body Art Regulations", as indicated in Attachment "A" hereto, and incorporated herein by reference.

2. That it is the intent of the Board of Health to consider repealing in whole the current El Paso County Board of Health Regulation 6 "Body Art Regulations" and to consider enacting in its place an amended Chapter 6 "Body Art Regulations", as indicated in Attachment "A".

2. That following said hearing, the Board of Health shall take action upon such regulations as it deems appropriate.

3. That Public Health shall advertise said public hearing as provided by law.
